### Health Questionnaire & School Health Review for Your Child

As part of the Universal School Health Services, and in line with governmental guidance (**DH, Healthy Child Programme from 5 - 19 years old, 2012**) you will be asked to complete a confidential health questionnaire for your child and for your child to have a School Health Review.

The health questionnaire asks if you have health concerns or if your child has known health conditions. This enables the School Health Service to ensure we provide the correct support for your child.

The health questionnaire is completed via the link below and will be automatically sent to our team. If you are having any issues with submitting the health questionnaire then please email our team [cnw-tr.kandcshs.cnwl@nhs.net](mailto:cnw-tr.kandcshs.cnwl@nhs.net) or call us on 020 3317 4460. The health questionnaire will be reviewed by the School Health Service who will offer advice and support to you and your child as needed. We may contact you if the School Nurse has identified any concerns.

Secondly, a School Health Review will be undertaken by the School Health Service for your child in school. The review includes a height and weight measurement, a hearing test and an eye test. Written consent is not required for this School Health Review. However, if you have any questions or concerns please contact the School Health Service on 020 3317 4460, within 2 weeks of receiving this letter.



**The hearing and vision screening will take place week commencing 23 September 2024. The opt out window is from September 9<sup>th</sup> to 22<sup>nd</sup>.**

If we do not receive contact from you, the School Health Service will assume that you are happy for your child to have this School Health Review in school.

Following the School Health Review if there are any concerns, the School Nurse will contact you to discuss further. Thank you in advance for completing the Parent Health Questionnaire and please do not hesitate to contact us.
